Introduction

The NOVAworks Workforce Board (NOVAworks) is a federally chartered workforce development board serving the Silicon Valley cities of Cupertino, Los Altos, Milpitas, Mountain View, Palo Alto, Santa Clara, and Sunnyvale, and the County of San Mateo. It helps individuals find and access employment and helps businesses find qualified candidates. Addressing the region's economic turbulence and frequent spasms of layoffs and hiring sprees, NOVAworks is seeking an Applicant Tracking System/Talent Management System tool enabling it to quickly match the skills and credentials of job seekers with employing hiring demands. (NOVAworks is a department of the City of Sunnyvale, CA)

Project Purpose and Description

NOVAworks is seeking a small-scale ATS to facilitate the matching of a job seeker's workforce skills, credentials, and qualifications with an employer's skill/job specifications. The system must include the following features: career page hosting to display open positions, receiving, sorting, and screening applications, and resumé storage. NOVAworks issues this Request for Quotations (RFQ) to solicit a response and detailed quotation from qualified vendors to provide a job match technology system, according to the features outlined below.

Desired Features of Applicant Tracking/Talent Management System

- Job seekers can easily upload multiple resumes without having to recreate a new profile each time. In addition, job seekers will have the option, if applicable, to complete a job application and provide additional information about qualifications in this portal. Job seekers' search for jobs are seamless and based on key words.
- The system is skills-based, and automatically records the skills identified by job seekers. This enables future job searches to be more effective.
- Employers can easily upload their job specifications and highlight specific skills required.
- The system will feature NOVAworks branding.
- The projected date for the system to be fully operational is by June 30, 2023.
